IN CONSIDERATION of being permitted to participate in any way in Punta Ala Tral Center ("Club") sponsored Events and Bicycling Activities ("Activities"), including Grinduro ITALIA, I for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of the Activities and that I am qualified to participate in such Activities. I further acknowledge that Activities will be conducted over public trails and facilities open to the public during the Activities and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURIES, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activities, the conditions in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation in the Activity.

\_\_\_\_\_RACE ABANDONMENT: I understand that if I choose to abandon the race for any reason, I will notify the nearest course marshal, neutral support rider, or aid station prior to abandoning. I understand that I will need to forfeit my timing chip and receive no time for any uncompleted stages.

\_\_\_\_\_I grant permission to all of the foregoing to use my photographs, motion pictures, recordings or any other record of this event for any legitimate purpose.

\_\_\_\_\_I understand that ride participants/course volunteers must abide by all applicable State and local vehicular laws. This includes, but is not limited to, riding as close as possible to the right-hand curb or edge of roadway and obeying stop signs. Bicyclists riding more than one abreast shall yield to vehicular traffic.

\_\_\_\_\_I understand that certain obstacles exist along the roadways, which could cause injury to riders. Attention is hereby directed to the many signposts, utilities, curbs, medians, guardrails, retaining walls, pavement markings, delineators, barricades, road bumps, uneven pavement, etc.
